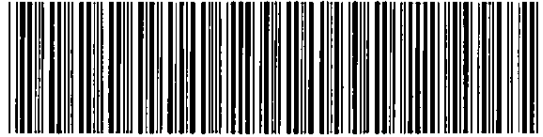

LLC. Except for this change, the Operating Agreement remains in full force and effect.

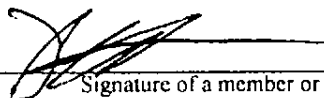
