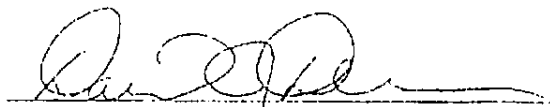

The Company's Members will manage the Company's business. The authorities and duties of the Members are set forth in the Operating Agreement.

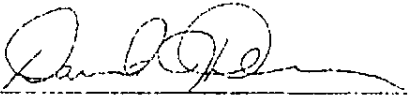
Section 1.12 Indemnification and Liability
