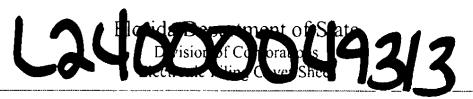

ARTICLES OF ORGANIZATION OF RANSOMRX LLC

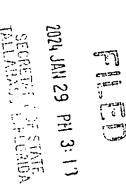
