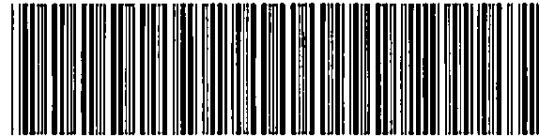

# ARTICLES OF ORGANIZATION OF TRANCHE CONSULTING AND MANAGEMENT LLC

## 1. NAME
