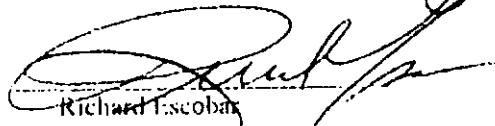
**ARTICLES OF ORGANIZATION

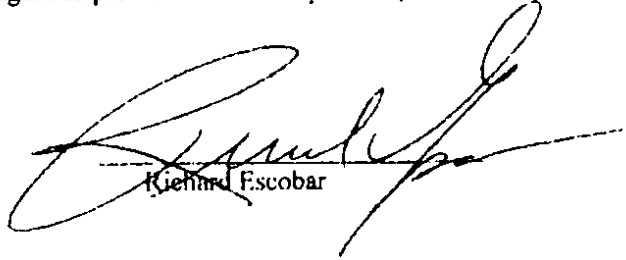
