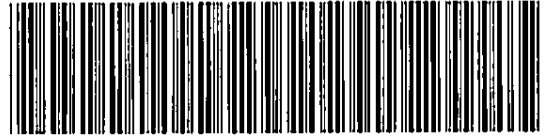

## **ARTICLES OF ORGANIZATION**

### **ARTICLE V DURATION**


The Company's duration shall be perpetual.
