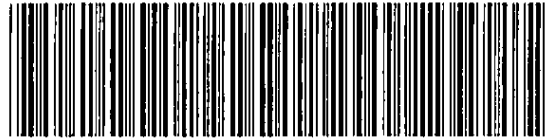



**SPECIAL AND REVOCABLE  
LIMITED POWER OF ATTORNEY**
