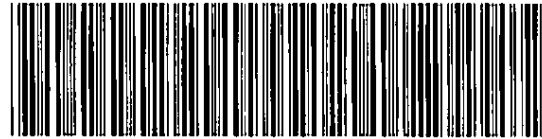

FIFTH: The members of the Limited Liability Company shall consist of not less than one Member. The name and address of the initial Members are:




