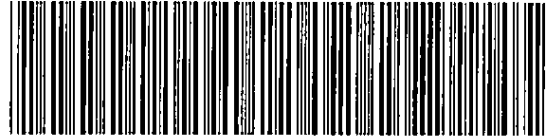



ARTICLES OF ORGANIZATION

OF


ARTICLE IX - MANAGEMENT

ARTICLE X - AMENDMENT

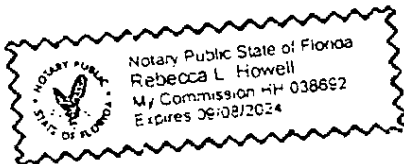



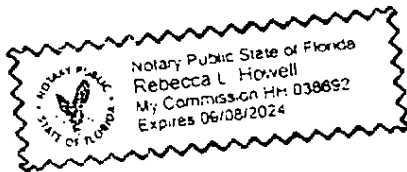
