**ARTICLE I  
NAME**

The name of the Company shall be: **HOLISTIC NEUROLOGY, LLC**

**ARTICLE II  
ADDRESS AND PLACE OF BUSINESS**

The address of the principal office and the mailing address of this Company shall be 2749 1st Avenue North, Unit 1/2, St. Petersburg, FL 33713, and such other places as may be designated by the Members from time to time.

**ARTICLE III  
PERIOD OF DURATION**

The Limited Liability Company shall exist perpetually, effective as of the date of filing these Articles of Organization with the Florida Department of State.

**ARTICLE IV  
GENERAL POWERS**

The Company is formed for the purpose of providing medical services and conducting and undertaking, and shall have the power to conduct and undertake, any and all activities and actions authorized under the Florida Revised Limited Liability Company Act, Chapter 605, *Florida Statutes* (the "Act").

**ARTICLE V  
MANAGEMENT BY THE MEMBERS; OPERATING AGREEMENT**

All powers of the Company shall be exercised by or under the authority of its Members as provided in the operating agreement of the Company (the "Operating Agreement"). The Operating Agreement shall provide for the regulation, management, and other affairs of the Company and shall not be in conflict with these Articles of Organization or with the Act or other applicable laws. The Operating Agreement may be amended or terminated only in the manner now or hereafter prescribed therein.

**ARTICLE VI  
AUTHORIZED MEMBERS AND OFFICERS**

The following person is designated as the Authorized Member and/or officer of the Company, and may enter into transactions on behalf of, or otherwise act for or bind, the Company and shall have such other duties and powers as specified from time to time by the Members or as set forth in the Operating Agreement:

Any person serving in one of the officer positions specified in this Article VI may sign on behalf of the Company, and third parties may rely on such officer's signature without need for further investigation.

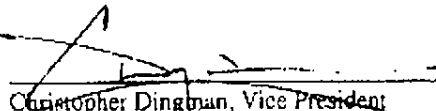
