**ARTICLES OF ORGANIZATION
OF

The undersigned hereby executes these Articles of Organization for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

ARTICLE I

Name

The name of this limited liability company (the "Company") shall be Address Healthcare Administration, LLC.

ARTICLE II

Principal Office and Mailing Address

ARTICLE III

Duration; Effective Date

The Company shall have perpetual existence.

Registered Office and Registered Agent

Notwithstanding the foregoing, in the event of any conflict between a provision of these Articles and the Operating Agreement as in effect at the time, the conflicting provision of the Operating Agreement shall control.

ARTICLE VI

Management


The Company shall be a manager-managed limited liability company. The authority, and limitations on such authority, of the manager shall be specified in the operating agreement of the Company.


