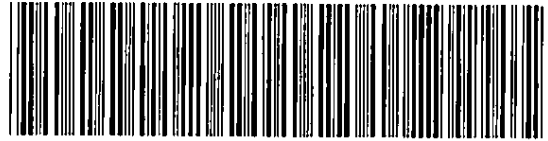

ARTICLE II: ADDRESSES




