ARTICLES OF ORGANIZATION
of
NDK SPORTS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605 (the "Act"), hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be NDK Sports, LLC (the "Company"). The mailing and street address of the principal office of the Company shall be 3235 Front Road, Jacksonville, Florida 32257.

ARTICLE II

PURPOSES AND POWERS

DURATION AND COMMENCEMENT


