

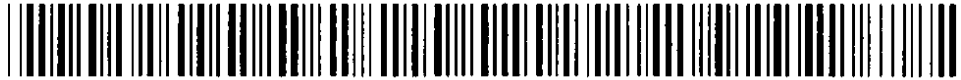


Article VIII


