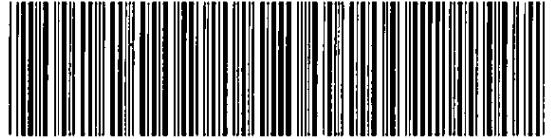

The name of the limited liability company is Happy Cans, LLC (the "LLC").

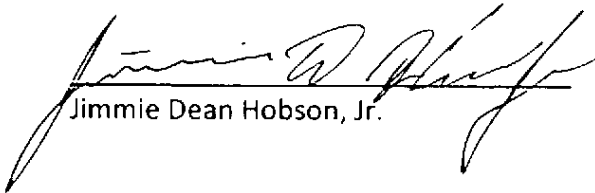
ARTICLE II: ADDRESS

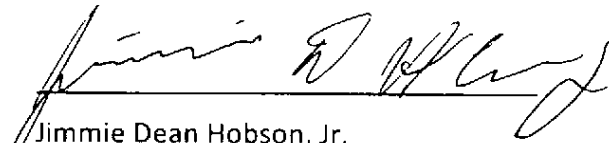

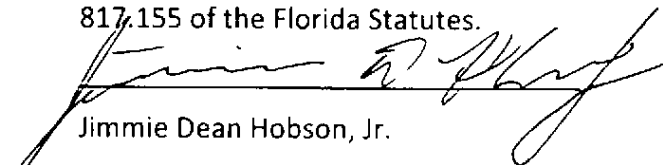
