**Articles of Organization
of

ARTICLE I - NAME

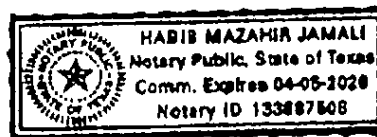


