ARTICLES OF ORGANIZATION of DNA ELITE GROUP, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605 (the ".4ct"), hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

PURPOSES AND POWERS
