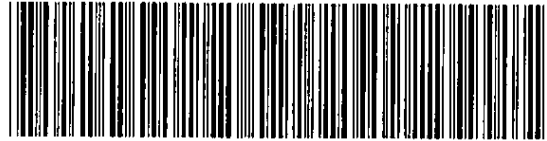


**ARTICLE VI

2. Any Transfer (as defined in the Franchise Agreement) is subject to the restrictions in the Franchise Agreement.




