**ARTICLES OF ORGANIZATION FOR

ARTICLE VI. OPERATING AGREEMENT.

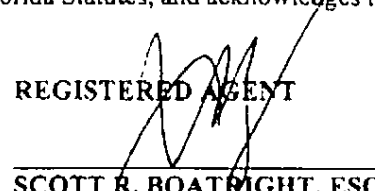
