ARTICLES OF ORGANIZATION

Wellborn, a natural person competent to contract and an authorized representative of Live Well Holdings Group, LLC, hereby presents these Articles of Organization as the Articles of Organization of Live Well Holdings Group, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I – NAME**

The name of the limited liability company is Live Well Holdings Group, LLC. This limited liability company is referred to in these Articles of Organization as the “Company.”

**ARTICLE II – PRINCIPAL OFFICE ADDRESS**
