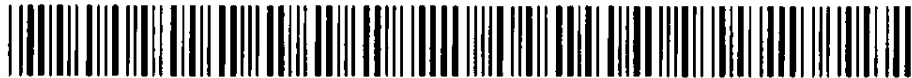

## ARTICLES OF ORGANIZATION OF SMARTTIX, LLC

The undersigned hereby executes these Articles of Organization for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.
