ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be Snappers - St. Augustine, LLC (the "*Company*"). The mailing and street address of the principal office of the Company shall be 233 Rivershore Lane, St. Augustine, Florida 32084.

ARTICLE II

PURPOSES AND POWERS


**ARTICLE VII****DURATION AND COMMENCEMENT**


