**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
WINTER GARDEN FLEX MANAGER, LLC**

Pursuant to the provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act, **WINTER GARDEN FLEX MANAGER, LLC** adopts the following Articles of Amendment to its Articles of Organization:

FIRST: The name of the limited liability company is Winter Garden Flex Manager, LLC (the "Company").

SECOND: The Articles of Organization of the Company were filed with the Florida Department of State on January 27, 2024, under Document Number L24000100920.

THIRD: The following amendments to the Articles of Organization were adopted by the Company:

Article I of the Articles of Organization is hereby corrected and amended and restated in its entirety to read as follows:

ARTICLE I – NAME

The name of the Company shall be Winter Garden Flex Manager, LLC

Article IV of the Articles of Organization is hereby amended and restated in its entirety to read as follows:

ARTICLE IV - MANAGEMENT

The Company shall be a manager-managed company. The managers of the Company shall be Jacob Williams and Sharon Williams, 12200 West Colonial Drive, Suite 303, Winter Garden, Florida 34787.
