**ARTICLE I  
NAME**

**ARTICLE V  
REGISTERED OFFICE AND REGISTERED AGENT**

The street address of the limited liability company's initial registered office in Florida is 2906 Bay to Bay Boulevard, Suite 200, Tampa, FL 33629, and the name of its initial registered agent is Thomas P. McNamara. 
