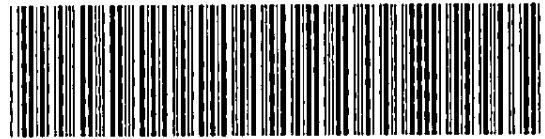

ARTICLE IV – Management:

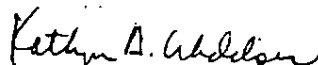
