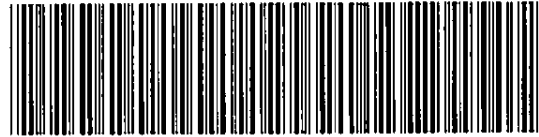

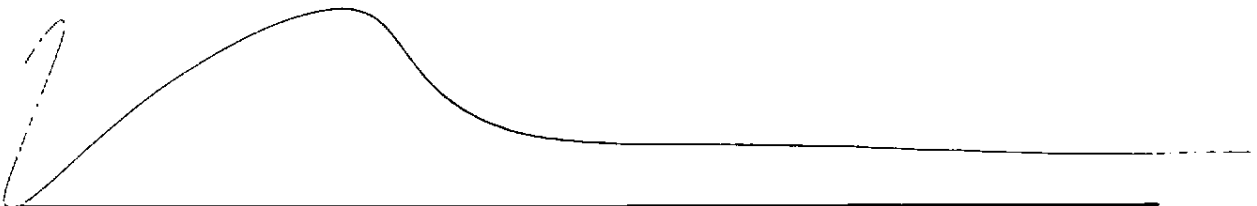

ARTICLE I - NAME

ARTICLE X - AMENDMENT

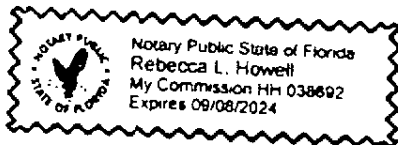
