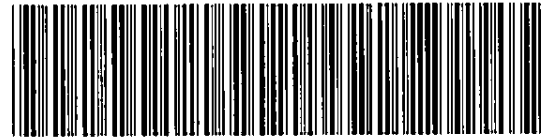

1. **NAME.**

3. **PURPOSE.**

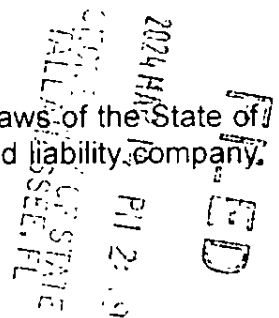


