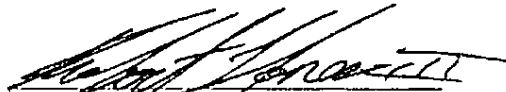
ARTICLE VII – Members

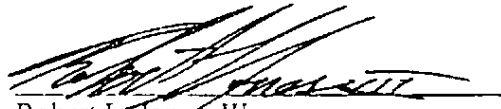
