**ARTICLES OF ORGANIZATION
OF
MONICO PINO LLC**

The undersigned, being an authorized representative of the Member(s), desiring to form a limited liability company under and pursuant to Chapter 605, Florida Statutes, does hereby adopt the following Articles of Organization:

**ARTICLE I
NAME**

The name of the limited liability company is **MONICO PINO LLC** (the "Company").

**ARTICLE II
ADDRESSES**

The Manager(s) shall serve in such capacity until his, her, or their successor(s) is/are duly elected and qualified.

The Effective Date of the Company shall be the date these Articles are filed with the Florida Department of State, Division of Corporations.




