**ARTICLES OF ORGANIZATION
OF

The undersigned, George Z. Aberth, D.D.S., a natural person competent to contract and an authorized representative of Aberth Family Dental, PLLC, hereby presents these Articles of Organization as the Articles of Organization of Aberth Family Dental, PLLC, a professional limited liability company formed under the provisions of Chapter 605 and Chapter 621, *Florida Statutes*.

ARTICLE I – NAME

The name of the professional limited liability company is Aberth Family Dental, PLLC. This professional limited liability company is referred to in these Articles of Organization as the “Company.”

ARTICLE II – PRINCIPAL OFFICE ADDRESS

ARTICLE III – PURPOSE AND POWERS
