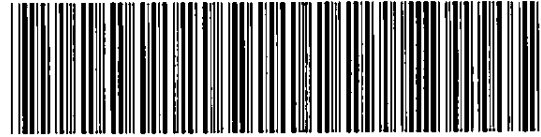

The mailing address and street address of the principal office of the Company is 276 NE Edgewater Drive, Stuart, Florida 34996.




