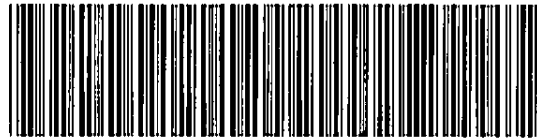

ARTICLE VI




