

# ADDENDUM TO ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY

## Vida Linda Holdings LLC

#### ARTICLE VI – MEMBERSHIP LIST

- 1. Economic Member. The economic member of this LLC shall have 100% of the obligation to make contributions to, and of the right to receive distributions from, this LLC. The initial economic member in this LLC is Mark Andrew Prada.
  - a. Designation of Non-Economic Member. The economic member shall be responsible for, and authorized to effect, the designation or change of the non-economic member. In the event of the non-economic member's death, incapacitation, or bankruptcy, the economic member shall promptly designate a new non-economic member with an effective of the date of such event.
- 2. Non-Economic Member. The non-economic member shall not have a transferable interest in, has no obligation to make a contribution to, and has no right to a distribution from, this LLC. See § 605.0401(4), Fla. Stat. (2024). The initial noneconomic partner in this LLC is Nicole Marie Torres.
  - a. Springing Membership. In the event of the economic member's death, incapacitation, or bankruptcy, the non-economic member shall become the economic member, and shall promptly designate a new non-economic member with an effective of the date of such event.
  - b. Transfer to Estate. In the event of the overlapping death, incapacitation, or bankruptcy (in any combination) of both the economic member and the non-economic member prior to the designation of a new non-economic member, the economic member's interest will transfer to the economic member's estate which shall promptly designate a new economic member with an effective date of the latter overlapping event.
- 3. Public Registration. The filing of this Membership List with the Articles of Organization for this LLC does not imply that future modifications to this Membership List must be publicly filed.
