## ARTICLE X - AMENDMENT

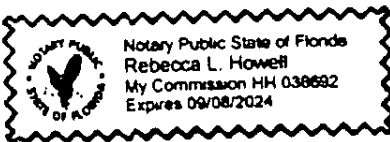

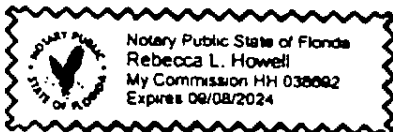
