**ARTICLES OF ORGANIZATION**

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605 (the "*Act*"), hereby makes, acknowledges and files the following Articles of Organization.

**ARTICLE I**

**NAME**

The name of the limited liability company shall be Fish House Holdings 2, LLC (the "*Company*"). The mailing and street address of the principal office of the Company shall be 233 Rivershore Lane, St. Augustine, Florida 32084.

**ARTICLE II**

**PURPOSES AND POWERS**
