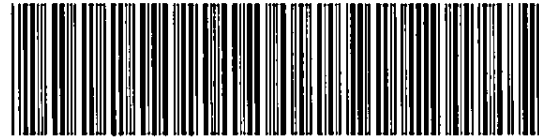

The name of the limited liability company is Innovation Medical Research Center LLC (the "Company").

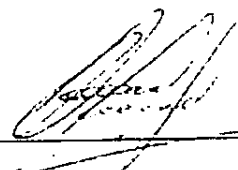
ARTICLE II. MAILING AND STREET ADDRESS
