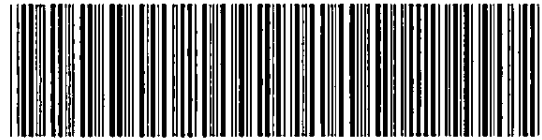

To help our clients to make good financial decisions in all aspects of their business to help them to grow sustainably and establish long-term relationships with our clients to support their needs in changing business climates.

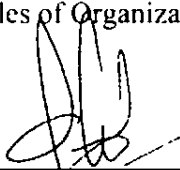

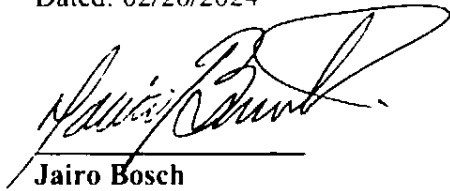
