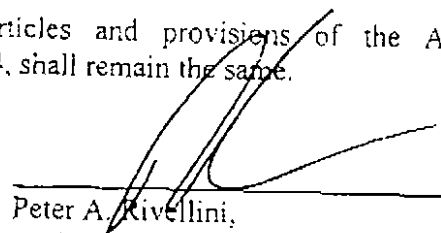
3. Amendment: This amendment is submitted to solely amend the following:
