# ARTICLES OF ORGANIZATION

OF

#### NEAL RENTALS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act (Chapter 605 of the Florida Statutes), does hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I -- NAME

The name of this limited liability company is Neal Rentals, LLC (the "company").
