I am the owner of Voice Choice Entertainment, LLC., registered in the State of Florida, with the registration number L17000240941.

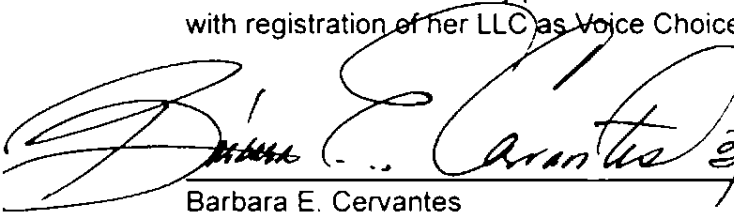

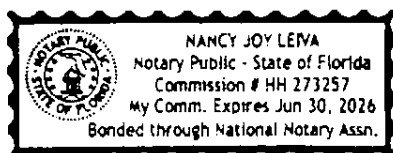
I consent to Denise Colon adopting the name Voice Choice Entertainment for her LLC and affirm that I have no objections to her using the name for her business endeavors.
