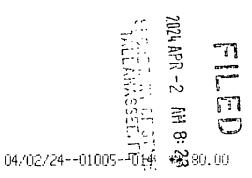

- 1. Name. The name of this limited liability company is David C. Brown Realty, LLC (the "Company"), and it shall be formed as a Florida limited liability company under Chapter 605. Florida Statutes.
