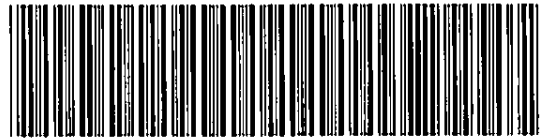

The street and mailing address of the principal office of the LLC is 18500 Wayne Road, Odessa, Florida 33556.

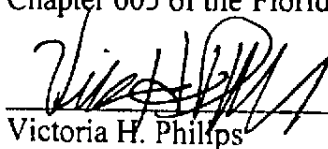

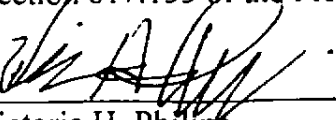
