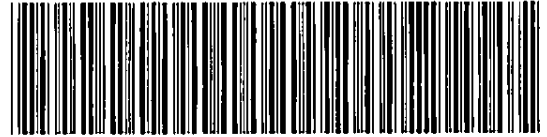



Management




