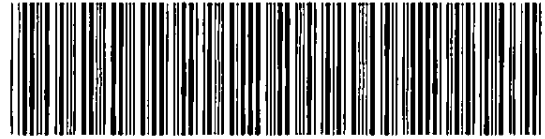

**ARTICLES OF ORGANIZATION OF

The undersigned, acting as the manager of 7408 Tom Drive, LLC (the "Company"), does hereby certify that said member has formed the Company to be a limited liability company under the laws of the State of Florida and under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, as amended (the "Act"), and, pursuant to the Act, hereby sets forth the following Articles of Organization:

ARTICLE I: NAME

The name of the Company shall be 7408 Tom Drive, LLC.

ARTICLE II: ADDRESS AND PLACE OF BUSINESS

The initial address of the principal office and the mailing address of the Company shall be 7408 Tom Drive, Land O Lakes, FL 34638.

ARTICLE III: DURATION AND PURPOSE

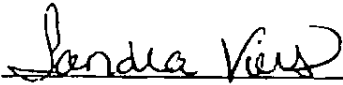
ARTICLE V: REGISTERED OFFICE AND REGISTERED AGENT
