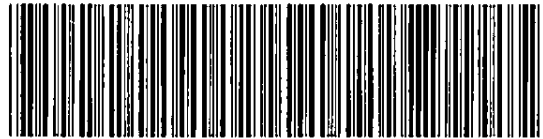

ARTICLES OF ORGANIZATION

OF

THE UNDERSIGNED, hereby adopts the following Articles of Organization for the purpose of forming a limited liability company Pursuant to s. 608, Florida Statutes, under the law of the state of Florida.

ARTICLE 1 - Name

The name of the limited liability company is BASS BOYZ XPRESS LLC.

ARTICLE 2 - Principal Office

ARTICLE 4 Manger or Managing Members

ARTICLE 5 - Commencement and Duration

The limited liability company is to commence its company existence effective upon filing hereof, and shall exist perpetually thereafter until dissolved according to law

ARTICLE 6 – Purpose and Powers

The limited liability company is to be organized for the purpose of transact any and all lawful business for which a limited liability company may be organized under the laws of the State of Florida. The company shall have all powers granted to a limited liability company under the laws of the State of Florida.

ARTICLE 7 – Admission of New Members

No additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and upon such terms and condition as shall be determined by all the members. A member may transfer his or her interest in the company as set forth in the regulations of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

ARTICLE 8 – Termination of Existence

The Company shall be dissolved upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or manager, or upon the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all the remaining members, provided there are at least one remaining member.

ARTICLE 9 - No Personal Liability

The private property of the manager or managing members shall not be subject to the payment of the limited liability company debts.

ARTICLE 10 - Indemnification

The limited liability company shall indemnify any present or former manager or managing members, or person exercising powers and duties of a manager or managing members, to the full extent now or hereafter permitted by law.

ARTICLE 11 - Operating Provisions

The Company shall be managed by a manager or members, in accordance with regulations adopted by the members for the management of the business and affairs of the Company. These regulations may contain any provisions for the regulations and management of the affairs of the Company not inconsistent with the laws of these Articles of Organization. Which may be amended from time to time by a majority vote of a quorum of the manager or managing members.

The articles of organization may be amended at any time by a vote of the majority of the manager or managing members voting, at any regular meeting, of the manager and managing members at any special meeting of the managers called for that purpose.

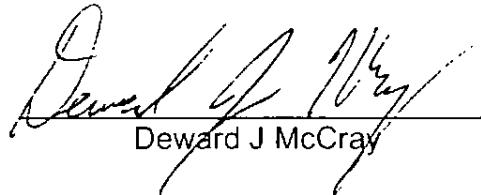

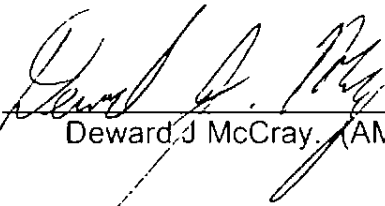

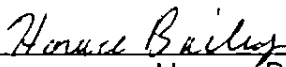
