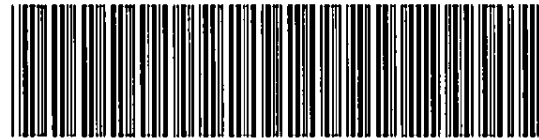

The Company shall have all powers given limited liability companies under the laws of the State of Florida. The period of duration of the Company is perpetual.

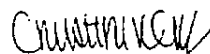
**ARTICLE IV**

The Company is to be managed by a Manager or Managers who will serve in accordance with the terms of the Company's Operating Agreement. The Manager is:

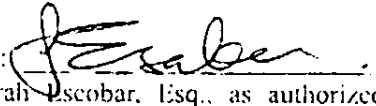
