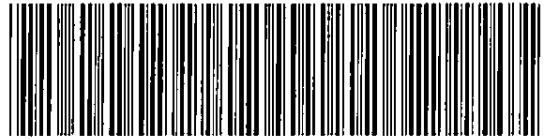





ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company pursuant to the Florida Limited Liability Company Act, F.S. Chapter 605, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I – NAME

The name of the Limited Liability Company is AT&P INTERNATIONAL, LLC.

ARTICLE II – ADDRESS

The initial manager will serve until the first annual meeting of the member(s) or until his successor(s) become duly qualified and elected. 
ARTICLE VIII – REGISTERED OFFICE AND AGENT


