**ARTICLES OF ORGANIZATION

The undersigned hereby organizes a limited liability company under the provisions of the Florida Revised Limited Liability Company Act (the "Act"), and pursuant to the following Articles of Organization:

ARTICLE 1

Name

The name of this limited liability company (the "Company") is "CDR Opportunity Fund, LLC".

ARTICLE 2

Effective Date

The Company shall have perpetual existence, commencing on the date that these Articles of Organization are filed with the Florida Department of State.

ARTICLE 3

Principal Office and Mailing Address

The street address of the principal office and the mailing address of the Company are 601 Bayshore Boulevard, Suite 700, Tampa, Florida 33606.

ARTICLE 4

Initial Registered Office and Agent

ARTICLE 5
Management of the Company

The Company is to be managed by one or more managers and is, therefore, a manager-managed limited liability company within the meaning of the Act.

ARTICLE 6
Purpose

The Company has been organized as a “qualified opportunity fund” for purposes of Sections 1400Z-1 and 1400Z-2 of the Internal Revenue Code of 1986, as amended (the “Code”). The purpose of the Company is to (a) invest in “qualified opportunity zone property” (as defined in Section 1400Z-2 of the Code or any successor statute or section thereto), (b) engage in any and all activities permitted under applicable law relating thereto so long as such activities continue to permit the Company to qualify as a “qualified opportunity fund,” and (c) engage in the trade or business of acquiring, owning, holding, investing in, operating, managing, selling, exchanging and otherwise dealing with real property and/or operating businesses, including through one or more “qualified opportunity zone businesses” (as defined in Section 1400Z-2 of the Code or any successor statute or section thereto).

ARTICLE 7
Indemnification

The Company shall indemnify its managers and members to the fullest extent authorized by law.
