

ARTICLES OF ORGANIZATION OF PEI GLOBAL PARTNERS HOLDINGS ASIA PACIFIC LLC

The undersigned, acting as the authorized representative of PEI Global Partners Holdings Asia Pacific LLC (the "Company"), does hereby certify that said member has formed the Company to be a limited liability company under the laws of the State of Florida and under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, as amended (the "Act"), and, pursuant to the Act, hereby sets forth the following Articles of Organization:

ARTICLE I: NAME

The name of the Company shall be PEI Global Partners Holdings Asia Pacific LLC.

ARTICLE II: ADDRESS AND PLACE OF BUSINESS

The initial address of the principal office and the mailing address of the Company shall be 1001 Water St., Suite 1150, Tampa, Florida 33602.

ARTICLE III: DURATION AND PURPOSE

The period of duration of the Company shall be perpetual. The Company is formed for the purpose of conducting and undertaking, and shall have the power to conduct and undertake, any and all activities and actions authorized under the Act.
