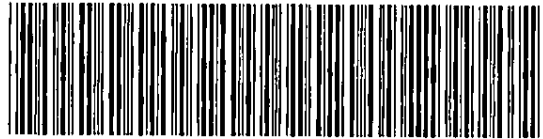

**ARTICLES OF ORGANIZATION  
OF  
MCFT FORT MYERS OUTPARCEL, LLC**

These Articles of Organization are submitted for the purpose of forming a limited liability company pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, as the same may from time to time be amended, superseded or replaced (the "Act").

**ARTICLE I – NAME**

The name of this limited liability company (the "Company") is **MCFT FORT MYERS OUTPARCEL, LLC**.

**ARTICLE II – ADDRESS**

The initial address of the principal office and the mailing address of the Company is 6725 Monument Dr., Wilmington, NC 28405.

**ARTICLE III – INITIAL REGISTERED OFFICE AND AGENT**


**ARTICLE IV – MANAGEMENT OF THE COMPANY**
